



Registration Information

We are pleased to invite participants from around the world to register for the 2nd Annual Conference on Foundation Decarbonization and Re-use, hosted by the Royal Society of Engineers and DFI Europe.

The registration fee is determined when payment is received, not by the date of submission. All fees are quoted in Euro.

Author / presenter registration requirements: In order to have a paper published in the open access tool, at least one author must register and pay by April 1st. One author is allowed to present up to two papers at the Conference.

Member rate: This rate is applicable to members of DFI and KIVI.

Student rate requirements and qualifications: Proof of student status is required to confirm the Student Rate. Proof consists of a copy of the student's identification card or a letter from the institution's registrar verifying student status. Please download this information in the registration form.
